The rest of the premise will remain supervised and after 9pm the entire premise will be supervised. This is in line with the Provisional LAP for Auckland which allows for undesignated areas in taverns for dining areas. This area is used principally for dining. There is no change to the licensed hours. (Online notice 27/11/20).
